- Revenue increased by 20%, while the cost of goods sold rose by 23%, resulting in a gross profit increase of VND 3,261,006,655 (7.2%).
- Financial expenses decreased due to the reversal of foreign exchange differences amounting to VND 6,732,780,173.
- Other income from asset disposal amounted to VND 2,272,727,273.
